Companies with controversial behavior in the form of severe or repetitive breaches to UN Global Compact principles (human rights, labour rights or the environment) are engaged or excluded from a.s.r. portfolios.

Companies involved in controversial activities as armament, tobacco, gambling, nuclear energy when representing more than 50% of the revenues, unconventional oil and gas when representing more than 5% of the revenues, conventional oil and gas when not Paris-aligned, are excluded from a.s.r. portfolios and listed below. For coal mining we maintain a zero-tolerance policy.
