General Meeting of Shareholders

The Annual Report is scheduled for discussion at the Annual General Meeting of Shareholders (AGM), to be held on 25 May 2022. In addition to the usual items, the agenda includes the proposal to reappoint supervisory director Sonja Barendregt. In May 2022, her current (first) four-year term of office will expire. The Supervisory Board of a.s.r. intends to nominate Sonja Barendregt for reappointment for a period of four years. In addition to being a member of the Supervisory Board, Sonja Barendregt is also chairperson of the Audit and Risk Committee. Shareholders can vote on her reappointment at the AGM on 25 May.

The full agenda and the accompanying documents for the AGM will be published by 12 April 2022.
